

**EXPRESSION OF INTEREST
EMPANELMENT OF MANUFACTURER FOR SUPPLY OF MDPE PIPE**

1 INTRODUCTION

1.1 Indraprastha Gas limited (IGL) (hereinafter referred as Owner), is supplying Piped Natural Gas (PNG) to domestic, commercial and Industrial consumers and Compressed Natural Gas (CNG) to automobiles in NCT of Delhi and NCR. IGL intends to extend the network to cover more areas of Delhi, UP, Haryana, Rajasthan and upcoming GAs to supply Natural gas to Domestic, Commercial consumers and automobile segment.

1.2 M/s. VCS quality services Pvt. Ltd. has been appointed as Engineering and Project Management Consultants (hereinafter referred as Consultant), by IGL for aforementioned empanelment in which IGL intends to empanel manufacturer for supply of MDPE pipes of dia (OD) from 20 mm. to 180 mm.

2 ELIGIBILITY CRITERIA

2.1 Interested bidder must have produced and supplied minimum 50 Kms. Of MDPE pipe (PE 80 / PE 100) / HDPE Pipe in accordance with relevant codes and standards for water / sewage / gas application in last 5 years reckoned from the date of bid submission,

2.2 Bidder must have valid IS:14885 certificate at the time of material supply.

2.3 Net worth of bidder must be positive for FY 2017-18.

Note:

A. Bidder shall submit minimum following documents to establish their credentials to meet Eligibility criteria

1. Purchase order copy
2. Copy of SOR of above purchase order clearly describing the scope of supply,
3. Certificate from owner certifying supplied quantity against the said PO and the duration during which this supply took place,
4. Copy of valid BIS certificate or undertaking for submission of BIS certificate at the time of material supply,
5. Copy of audited financial report for FY 2017-18,
6. Annexure-I.

B. The bidder is required to submit the documentation and proof for above requirements to owner and IGL may at its discretion make additional checks for the same.

C. The offer shall be submitted to Owner in a sealed envelop super scribing **Ref. No. – EOI/PNG/03/2019** and material(s) for which offer has been submitted.
