IGL SIGNS LONG TERM AGREEMENT WITH DTC TO SUPPLY CNG

Agreement to remain in force till December 2030

New Delhi, March 31, 2021: Indraprastha Gas Limited (IGL), the largest Compressed Natural Gas (CNG) distribution company in the country today signed a long term gas supply agreement with Delhi Transport Corporation (DTC), to supply CNG for a period of ten years till December 2030 in the presence of Mr. Kailash Gahlot, Transport Minister, Govt. of NCT of Delhi. Mr. A.K. Jana, Managing Director, IGL signed the agreement on behalf of IGL, while Mr. Vijay Kumar Bidhuri, Managing Director, DTC signed the agreement on behalf of DTC. Senior officials of Delhi Government, IGL and DTC were also present on the occasion.

DTC is the largest CNG-powered bus service operator in the world with a fleet size of 3762 buses at present and is also in the process for procurement of 1000 new CNG buses which would shortly be plying on the roads of the national capital. DTC consumes around 2.80 lacs kgs of CNG per day for its buses which constitutes around 11% of daily CNG sale of IGL. The consumption of CNG is expected to increase further after the addition of new buses.

Earlier in 2010, IGL had signed the long term Gas Supply Agreement with DTC to supply CNG. As a part of the agreement, dedicated CNG filling facilities have been set up at 44 depots of DTC across Delhi and Noida to cater the fleet of DTC buses being used for public transport with a total compression capacity of 10 lakh kgs per day. These state of the art CNG filling facilities have helped in timely CNG fueling of the fleet. The initiative has resulted in optimization of time, finances and resources for DTC apart from ensuring timely commute of the buses on their respective routes. In addition, DTC has provided 19 plots adjacent to its depots to IGL for creation of hybrid facilities, which are used as retail outlets for serving the public.

The relationship between IGL and DTC dates back to inception of IGL and has been mutually beneficial for both organisations and DTC has been one of the largest customers of IGL.

Company Profile

About IGL – IGL is a joint venture of GAIL (India) Ltd. and BPCL along with Govt. of NCT of Delhi. The role of IGL in checking the vehicular pollution in the National Capital Region is well acknowledged both at national as well as international forums. IGL has well laid out its city gas distribution infrastructure in Delhi, Noida, Greater Noida, Ghaziabad, Rewari, Gurugram, Karnal, Kaithal, Fatehpur and Muzaffarnagar, which consists of over 15000 Kms of pipeline network. IGL is meeting fuel requirements of over 12 lakh vehicles running on CNG in NCR through a network of 560 CNG stations. IGL is supplying PNG to nearly 16 lakh households in these cities. The pipeline network is being further expanded by IGL to cover Ajmer, Pali and Rajsamand in Rajasthan, Shamli, parts of Meerut, Hamirpur and parts of Kanpur in Uttar Pradesh.
