ORDER (Through Virtual Mode)

20.09.2021: Heard Learned Solicitor General. He submits that the Appellant is a Public Ltd. Company by shares and it was formed as a Joint Venture between GAIL, Bharat Petroleum and the Government of Delhi.

Subsequently, the Company was authorised by the Central Government for supplying Natural Gas in Delhi, Gurgaon, Faridabad, Noida, Gr. Noida and Ghaziabad.

The Respondent has filed an application against the Appellant under Section 9 of IBC. Learned Adjudicating Authority on 16th September, 2021 in

open court pronounced the order "Petition Admitted. CIRP Initiated". However, the order has not been uploaded till date.

It is submitted that there is a pre-existing dispute. However, the Ld. Adjudicating Authority admitted the application and initiated CIRP. If the charge of the Company is taken over by the IRP then it will disrupt the supply of PNG and will affect the public at large. Therefore, the Impugned order may be stayed. It is also submitted that the Appellant has applied for certified copy of the order dated 16.09.2021. However, the copy has not been supplied till date.

Learned Counsel appearing on behalf of the Respondent No.1 also admits this fact that the order has pronounced on 16.09.2021 but not uploaded on the website.

We have considered the peculiar facts of this case in which the order of initiation of CIRP has been passed but the same has not been uploaded as yet.

Therefore, we stayed the operation of the impugned order till the next date of hearing.

The Appellant is directed to file the certified copy of the impugned order as soon as he gets the same.

Copy of this order be sent to concerned Adjudicating Authority forthwith for compliance.
