UPON hearing the counsel the Court made the following
O R D E R

During the course of hearing, learned Additional Solicitor General suggested that it might be worth considering whether the supply of natural gas by Haryana City Gas Distribution Limited (HCGDL) can be taken over by Indraprastha Gas Limited (IGL) in Gurgaon District as an ongoing concern so that the entire dispute can be resolved amicably.

Learned counsel for HCGDL and learned counsel for IGL are agreeable to this suggestion given by learned Additional Solicitor General.

It is also agreed between the parties that the valuation of the ongoing concern including the infrastructure (pipeline, etc.) may be valued by an independent valuer such as Deloitte Haskins and Sells LLP.

A copy of this order may be furnished to Deloitte Haskins and Sells LLP by learned counsel for the parties with a request to give the valuation within four weeks

from today and in any case by 30th November, 2018. The expenses to be incurred by Deloitte Haskins and Sells LLP will be borne equally by HCGDL and IGL.
