## **OVERALL EMPANELMENT PROCESS**

### **1.0 INTRODUCTION:**

Incorporated in 1998, IGL took over Delhi City Gas Distribution Project in 1999 from GAIL (India) Limited (Formerly Gas Authority of India Limited). The project was started to lay the network for the distribution of natural gas in the National Capital Territory of Delhi to consumers in the domestic, transport, and commercial sectors. With the backing of strong promoters – GAIL (India) Ltd. and Bharat Petroleum Corporation Ltd. (BPCL) – IGL plans to provide natural gas in the entire capital region.

### **2.0 BRIEF ABOUT EOI:**

Indraprastha Gas Limited (“IGL” or “Company”), a leading City Gas Distribution (CGD) company in Delhi & NCR, is expanding its infrastructure to ensure safe and efficient natural gas supply to industrial and commercial customers. To support this growth, IGL invites Expression of Interest (EOI) from competent contractors for their empanelment for execution of Internal Piping Work (IPW) for IGL Industrial & Commercial Customers in Delhi & NCR.

Through this EOI, IGL aims to identify and empanel capable contractors who meet the Empanelment Qualification Criteria (EQC), including technical expertise, relevant execution experience, availability of skilled manpower and adherence to safety and quality norms. The empanelment will help streamline the IPW execution process, enhance customer experience, and ensure uniformity, transparency, and compliance across industrial and commercial piping installations.


### **3.0 STEPS FOR CONTRACTOR EMPANELMENT :-**

#### **3.1 SUBMISSION OF EOI: To be submitted before the expiry of EOI validity period :**

EOI along with supporting documents must be submitted by the interested contractor on the IGL website, before the expiry of validity period.

## 5.0 SUBMISSION OF DOCUMENTS

The Party(ies) shall undertake to submit following document(s) in support of empanelment criteria in the EoI (as applicable):

### List of documents to be submitted for compliance to Techno-commercial EQC :

All documents (as applicable) in support of techno-commercial criteria (as applicable) of EQC to be furnished by the applicant shall necessarily be duly certified / attested and details be provided on the letterhead of statutory auditor or independent chartered accountant through a UDIN-unique document identification number (as applicable).

### NOTE-

- Submission of amply clear, unambiguous, legible scan copies, authentic documents as per various requirements and formats mentioned in the EoI is the prime responsibility of the interested party.
- IGL requires that Interested Party observe the highest standard of ethics during the course of participating in the EoI and not to indulge in any fraudulent practices in its dealings with IGL.
- By participating in the EoI, Interested Party expressly confirm and stand guarantee that none of the documents are false/forged or fabricated. All the documents submitted has been made having full knowledge of

- Maximum 50 numbers of contractors will be empaneled through this EOI, which will be further extendable as per requirement of IGL. The selection criteria will be as follows:
  - (a) Bidder having higher turnover as per the audited financial results during preceding three financial years. In case of tie, following point shall be followed.
  - (b) Bidder having successfully executed similar work of higher value in a single order during last 7 years from the date of EOI submission.
- Review on revision of Empaneled contractors will be done in every 2 years.
- Revision of Rates will be done in every 2 years.
