## Other details for land required in Kanpur, Hamirpur and Fatehpur

Proposals should be submitted by considering the following terms and conditions, failing which the offer will be rejected:

1. Lands as per following are required in Kanpur, Fatehpur and Hamirpur.
  - a) **Land for City Gas station in Kanpur:** Preferably 3 Km from NH-19 towards Kulgaon on either side of NH-19 to Kulgaon Road in Kanpur- Uttar Pradesh, having area of 1200-1500 sqr. mtrs and front of preferably 30-40 meters on purchase basis.
  - b) **Land for De-Compression Unit in Kanpur:** Approx. 160 sqm (Square meter) land with minimum 8 meter front and on minimum 7.5 meter road is required for setting up of De-compression Unit on lease basis, preferably In Kulgaon/ Ruma Village/ Hathipur.
  - c) **Land for De-Compression Unit in Fatehpur:** Approx. 160 sqm (Square meter) land with minimum 8 meter front and on minimum 7.5meter road is required for setting up of De-compression Unit on lease basis With-in 2 Km area of Aawas- Vikas colony
  - d) **Land for De-Compression Unit in Hamirpur:** Approx. 160 sqm (Square meter) land with minimum 8 meter front and on minimum 7.5meter road is required for setting up of De-compression Unit on lease basis With-in 1 Km from Kashi Ram Colony/ Jail Talab.

\*Bidder may send EOI for more than one options of lands and for more than one land for each option.

  - C) Envelope-III: Super scribing "**PROPOSAL FOR DOCUMENTS OF LAND REQUIRED FOR CGS IN KANPUR**" OR "**LAND REQUIRED FOR DCU IN KANPUR/FATEHPUR/HAMIRPUR.**" This envelope will contain Envelope-I & Envelope-II.
